Designed for:

This course is designed for elected Safety and Health Representatives (SHRs) and Deputy SHRs, who completed the Initial 5 Day course within the state jurisdiction of WA and need to refresh their knowledge, skills and confidence to represent their workplace. Evidence of attending the Initial 5 day training program will need to be provided. Note: You will need to provide evidence that you are a currently elected SHR

Pre-entry Requirements:

The refresher course can only be undertaken if the participant has completed the Initial 5 Day WA SHR course, evidence of this will need to be provided prior to attending refresher training

Description:

The purpose of this course is to revitalise the knowledge and skills to enable you to continue to exercise your powers for the purpose of promoting and ensuring the health and safety at work of members of your work group.

Content:

The course content covers:

- Critical areas of the legislation
- Hazard identification, risk assessment and control (hierarchy of control)
- Consultation, issue resolution, communication and representation
- Inspections and Investigations
- Issuing PINs
- Accessing information and basic record keeping
- Committees

Assessment:

There is no formal assessment as part of this course. Upon successful completion, participants will receive a Certificate of Attendance issued by Fire and Safety Australia Pty Ltd
